My publications across multiple disciplines (Figure 1) demonstrates the breadth of my contributions to medical anthropology; transcultural psychiatry; cross-cultural psychology; global public health; and human rights.

**Journal esteem.** I have published in highly ranked journals across these fields as judged by Scimago Journal & Country Rank (SJR) prestige indicator, e.g. *Social Science & Medicine* SJR 1.739, *Child Abuse & Neglect* SJR 1.7,

*Transcultural Psychiatry* SJR 0.716.

Since 1981, I have produced a career total of 300 publications (including 1 edited book, 22 book chapters, 73 journal articles, 59 conference proceedings, 7 published reports, 9 web-mounted publications, 18 reports, 71 invited papers and 54 other conference papers, a selection of which is in D8-ii). 175 of these publications have attracted a total of **5,445 citations**, (on 17 December 2018) resulting in an h-index of 29 (see Web of Science Cited Reference Index). I am sole or first author of three-quarters of my publications. In the social sciences, unlike the multi-authored series of papers in STEM sciences, such outputs often represent long periods of intensive research. My publications benchmark highly in relation to expectations in my various disciplines and fields.

**Bereavement.** My seminal papers on **cross-cultural aspects** of bereavement have become classics in bereavement studies for both western and resource-poor countries. This work is based on participation in a landmark project of the US Institute of Medicine, and published in *Culture, Medicine & Psychiatry* [H index 46] (325 citations). This work gave rise to a new concept, '**cultural bereavement**', first published in *Social Science & Medicine* [I.F. 2.733, H index 195] (625 citations). This led to a series of single-author publications in *Journal of Refugee Studies* [I.F. 5, H index 37] (20 citations), *Journal of Nervous and Mental Disease* [I.F. 1.682] (110 citations), *Journal of Intercultural Studies* [I.F. 1.054, H index 20] and *Collegium Antropologicum* [H index 33] (16 citations) and in a publication on acculturation and homesickness (9 citations). The concept of cultural bereavement has changed thinking about the mental health of diasporas, trauma, and approaches used in refugee and migration studies.

**Trauma and post-traumatic stress.** My publications on trauma and post-traumatic stress in authoritative journals such as *Social Science & Medicine* (590 citations), *Journal of Nervous and Mental Disease* (91 citations), *Journal of Traumatic Stress* [I.F. 2.721 (94 citations), H index 111] in collaboration with Professor Joop de Jong and Willem van de Put and *Social Psychiatry & Psychiatric Epidemiology* [IF 2.537, H index 97] with my PhD student Dzenana Kartal have challenged predominant views across a range of disciplines. They have evolved from an early challenge to the then-popular argument for the universality of PTSD and critical debate on the medicalisation of human suffering (see Summerfield) and on modern theories of PTSD (921 cross-citations). Research on disasters is published in *Journal of Religion and Health* [H index 27]. My esteem is further indicated in invited book reviews to prestigious journals such as *Journal of the Royal Anthropological Institute* [I.F. 1.229, H index 50].

**Mental health.** My earliest papers from the 1980s focused on depressed mothers and their children, and were published in *Journal of Paediatrics and Child Health* [I.F. 1.0, H index 65] and in invited contributions

to edited volumes by luminaries such as E James Anthony. In collaboration with Professor Gordon Parker, former Executive Director, Black Dog Institute and my PhD student Bibiana Chan, I have published on depression among Chinese immigrants, in *Psychological Medicine* [I.F. 6.159, H index 170] (84 citations). With Professor Clive Adams, I published a systematic review of fluphenazine, in the *Cochrane Database* [I.F. 6.124] (93 citations). Other papers on cultural aspects of mental health services for Chinese patients, published in *International Journal of Social Psychiatry* [I.F. 1.147, H index 91] (90 citations) and, in collaboration with the George Institute, on risk reduction among young drivers, published in *Injury Prevention* [I.F. 1.693] (58 citations), continue to influence service providers. Further publications in psychosomatics and the mind-body, starting with ‘wind illness’, were published in the prestigious *British Journal of Psychiatry* [I.F. 7.06, H index 192] (46 citations) and *Keio Journal of Medicine*, and with my PhD student Husna Razee on women in the Maldives.

**Culture and meaning.** Cross-cutting these papers is the examination of *meaning* of illness. My earliest published papers during the 1980s, influenced by my mentors Professors Arthur Kleinman and Leon Eisenberg at Harvard, were on cultural Explanatory Models, and published in journals such as *Psychiatric Clinics of North America* [I.F. 2.134, H index 82] (103 citations). Even after 25 years, students and researchers continue to adapt my Mental Distress Explanatory Model questionnaire in numerous settings across Africa, Asia and the Americas.

**Non-Communicable Disease (NCD).** Three multi-authored papers on **cancer** have been published in top-ranking journals in the field, including the prestigious *Nature* [I.F. 40.137, H index 1,011] (2,229 citations), *BMC Medicine* [I.F. 7.249, H index 87], *PloS One* [I.F. 2.806] and *Cancer Epidemiology and Prevention Biomarkers* [H index 166]. Collaboration with leaders in psycho-oncology such as Professor Phyllis Butow (University of Sydney) has resulted in a series of multi-authored publications between 2003-16 on cancer care for culturally and linguistically diverse communities, in which my contribution was on cultural competence, in *Journal of Clinical Oncology* [24.008, H index 463] (55 citations), *Annals of Oncology* [I.F. 11.855, H index 190] (15 citations), *European Journal of Cancer* [I.F. 5.417, H index 170] (29 citations), *Psycho-Oncology* [I.F. 2.443, H index 113] (93 citations), *Patient Education & Counseling* [I.F. 2.232, H index 107] (49 citations), *Asia-Pacific Journal of Clinical Oncology* [I.F. 1.959, H index 18], and *Cancer Forum* [H index 11]. Other papers were published in *Supportive Care in Cancer* [I.F. 2.698, H index 87] (65 citations) and *Quality of Life Research* [I.F. 2.334, H index 118], and have influenced the provision of cancer care services. A seminal report in collaboration with my Harvard exchange student Lauren Handelman on astrocytoma, published in *Social Science & Medicine* (44 citations) has influenced cultural consultation in oncology. Another line, published with my PhD student Abbas Haghshenas and Professor Patricia Davidson, was on cultural competence in **heart health**, published in *Journal of Clinical Nursing* [I.F. 1.278, H index 78] (17 citations). These publications have informed health literacy and in primary prevention of illness such as diabetes.

**Genetics.** My research has provided the intellectual scaffolding for transcultural understanding of **genetics**. An early paper with Menahem and Handelman on cultural influences on Mucopolysaccharidosis VI, published in *Clinical Paediatrics* [I.F. 1.371, H index 54], is cited in textbooks on inborn errors of metabolism. Co-authored publications with Professors Meiser and Barlow-Stewart that appeared in *Genetics in Medicine* [I.F. 8.229, H index 95] (57 citations), *Social Science & Medicine* (43 citations) and *Journal of Medical Genetics* [I.F. 5.451, H index 148] (42 citations) have significantly influenced genetic counselling services in Australia.

**Cultural competence.** Several of my publications have influenced medical and nursing education in Australia, appearing in journals such as *Journal of Psychiatric Education*, *Medical Journal of Australia* [I.F. 3.369, H index 112] (29 citations) and *Australian Mosaic*. These publications enriched the evidence base for multicultural health in Australia – federally, the Productive Diversity Partnerships Program of the Department of Immigration and Multicultural Affairs and, at a statewide level, NSW Health. In the Mekong Region, a cultural toolkit for UNESCO’s cultural diversity lens framework (Programme IV.2 MLA IV 222) was published on the UNESCO website.

**Traditional healing and Buddhist studies.** During the 1990s, I worked at the National Centre for Scientific Research where, in collaboration with Francophone scholars, I published a series of papers on traditional healing in *Homme, Bulletin de l'École française d'Extrême-Orient* (64 citations), and *Péninsule*, among the



most prestigious Francophone journals in both social sciences and mainland Southeast Asian scholarship. I also published on indigenous taxonomies, and on traditional healers and social justice, in *Bulletin of the Royal Institute for Inter-Faith Studies* and incorporated in community mental health service development in Cambodia, in an article in *Social Science & Medicine* co-authored with PI van de Put and Professor Daya Somasundaram, have been applied in Cambodia to community mental health (78 citations). These publications have influenced the burgeoning field of Buddhist psychotherapy. This body of work has been widely cited by authors globally including in Ethiopia, South Africa, Zimbabwe, Mozambique, China and Southeast Asia and in studies on refugees in Australia and New Zealand.

**Children.** An early publication on the mental health of refugee children published in *International Migration Review* [H index 77] continues to be widely cited (171 citations). It was followed by the first description, published in *Clinical Child Psychology and Psychiatry* [I.F. 1.145, H index 174], of indigenous concepts of childhood illness in Cambodia. The esteem of this body of work is evidenced by chapters in multiple editions of textbooks of global child and adolescent mental health. My collaborative research in Australia on state-wide programs such as Families First, was published in *European Journal of Clinical Nutrition* [I.F. 2.709, H index 129] (18 citations).

**Culture and Communicable Diseases.** My Francophone publications, e.g. in *Sociétés Asiatiques face au Sida*, focused on contagious and communicable diseases. Reports for agencies such as UNESCO/UNFPA have influenced the national HIV/AIDS program in Cambodia and national social marketing programs for malaria prevention.

**Cultural context of violence.** Since 2000, my trajectory, supported by ARC DP and LP grants, has focused on violence in Cambodia. A series of chapters (2000-4) with PI van de Put identified violence in the context of community mental health. A chapter published by UN University Press was the first to identify cultural competence in post-mass-crime peace-building. Recent papers on mass fainting, published in *Transcultural Psychiatry* [I.F. 2.28, H index 40] and *Journal of Religion and Health*, add to knowledge on structural violence. Publications on direct violence have appeared in the *ANZ Journal of Psychiatry* [I.F. 3.407], violence against women, in *Culture, Medicine & Psychiatry* [I.F. 1.288, H index 46], and on the cultural epigenesis of child abuse in Cambodia, in *Child Abuse & Neglect* [I.F. 2.397, H index 114], the benchmark journal in the field. and on child abuse, are a breakthrough in mapping the cultural epigenesis of violence and challenge the extant Theory of Change, providing the evidence base for this Proposal. Two publications on impunity, in *International Journal of Human Rights* [H index 11], apply the discovery of cultural epigenesis and are expected to influence scholarship in human rights and public violence.
